- (2) Papers submitted for publication in the next volume should reach the Editor, complete in all respects and ready for the printer, by 30th September.
- (3) Changes of address and errors in the list of members should be notified at once to the Hon. General Secretary.¹
- (4) An expansion of the membership would enable the Society to publish a larger volume of their Transactions and to undertake extended archæological work generally. Members, therefore, are urged to induce their friends interested in archæology to join the Society. Information as regards the Society's activities, copies of the Rules and forms of application for membership may be obtained from the Hon. General Secretary.¹
- (5) The annual subscription of ten shillings covers all the privileges of membership, but additional contributions in the form of annual or occasional donations to the Illustrations Fund, towards excavation work, or for the general purposes of the Society, and new subscribers to the Records Branch, are invited and are always very welcome.
