Abstract

Archaeology South-East was commissioned by Doug Hume to carry out a watching brief during the construction of a new detached dwelling behind No 5 High Street, Sevenoak s, Kent.

With the possible exception of a probably post-medieval/modern mortar floor, no significant archaeological features or finds were revealed.

1.0 INTRODUCTION

- 1.1 Archaeology South-East (ASE), a division of University College London Centre for Applied Archaeology (UCLCAA), was commissioned by Doug Hume to undertake an archaeological watching brief during ground works associated with the demolition of an existing garage block and the construction of a new detached dwelling with integral garage on land to the rear of No. 5 High Street, Sevenoaks, Kent, henceforth referred to as 'the site' (NGR 553108, 154159; Figure 1).
- 1.2 The site is located at the southern end of Sevenoaks High Street, c. 50m south-west of the junction with Oak Lane. The site lies in the footprint of a demolished garage immediately to the rear of No. 5 High Street, Sevenoaks. The site is bounded to the west by the car park to the rear of The Royal Oak Tap Public House, and to the south and east by properties off the High Street. The underlying geology, according to the British Geological Survey map is Folkestone Beds.
- 1.3 Planning permission was granted by Sevenoaks District Council for the construction of a detached dwelling with integral garage (planning ref. SE/04/02601). Following consultation between Kent County Council and the council's own Heritage Conservation Group, a condition was attached to the permission requiring that:

'No development shall take place until the applicant, or their agents or successors in title, has secured the implementation of a watching brief to be undertaken by an archaeologist approved by the Local Planning Authority so that the excavation is observed and items of interest and finds are recorded. The watching brief shall be in accordance with a written programme and specification which has been submitted to and approved by the Local Planning Authority.'

- 1.4 A Specification for the watching brief was produced by the Heritage Conservation Group, Kent County Council (KCC, 2005). Details of the techniques to be used were set out in the specification, a copy of which is contained within the archive. The specification also stated that if significant remains were revealed during the watching brief, further archaeological measures might be required to secure mitigation on the site. The specification provided background information which has been re-used in this report with due acknowledgement.
- 1.5 The watching brief produced negative results and the present document constitutes a 'Watching Brief Report' (as defined by Heritage Conservation Group, KCC).
- 1.6 The watching brief was carried out over two days, 7th and 9th April 2009, by Greg Priestley-Bell (Senior Archaeologist), the project was project managed by Neil Griffin (fieldwork) and Dan Swift (post excavation).

2.0 HISTORICAL AND ARCHAEOLOGICAL BACKGROUND

- 2.1 The site lies within the medieval and post-medieval settlement of Sevenoaks with several properties from these periods within the vicinity. St Nicholas's Church lies c. 135m to the north of the site and originates from the medieval period. The origins and form of Sevenoaks as a medieval settlement are unclear but it is thought at present that the historic centre of Sevenoaks, including the medieval market area, lay in the area of St Nicholas's Church. The market may have moved in the 13th century into the triangular area formed by the convergence of London Road and the High Street to the north of the site.
- 2.2 The Historic Environment Record (HER) maintained by KCC, and held at County Hall, Maidstone, was consulted and the results are summarised below. Details were taken of all archaeological sites and listed buildings within a 500 metre radius of the centre of the site. The identified sites (numbered 1 82) are tabulated below, and plotted on Figure 2.

2.3 Cartographic evidence

- 2.3.1 The 1769 Andrews, Dury and Herberts map (not included) appears to shows an L-shaped building on the corner of High Street and Oak Lane (south side); no adjacent buildings are shown on the subject site. Hasted's 1799 map (not included) shows a single stylised building on the corner, while the 1800 OS field drawing (not included) shows the same L-shaped building; the map does not extend any further to the south (Heritage Conservation Group, 2004).
- 2.3.2 It is not until the 19th century that No. 5 High Street is clearly defined. The 1870 OS map (not included) shows the inverted L-shaped building immediately to the north (the present Royal Oak Tap Public House) as a 'Hotel' and No 5 High Street much as it is today; a now disappeared square building is shown on, or immediately adjacent to, the subject site. No trace of this building was identified during the current work.

3.0 METHODOLOGY and AIMS

- 3.1 A continuous watching brief was maintained during the hand excavation of strip footings and test holes (Figures 3 and 4). The footings trenches were c. 1m wide and c. 1m deep below existing ground level (Plate 1), while the test holes were up to c. 0.50m wide and c. 0.50m deep.
- 3.2 Archaeological monitoring was conducted following the details of the techniques to be used set out in the specification document (KCC, 2005). Archaeological monitoring included an inspection of excavated material in order to identify and retrieve artefacts and ecofacts, and an examination of exposed surfaces for archaeological remains.
- 3.3 Provision was made for all identified significant archaeological remains to be recorded to accepted professional standards and in accordance with Standards and Guidance: watching brief of the Institute for Archaeologists (IfA). Provision was also made for the collection of environmental samples from appropriate deposits no such deposits were encountered. Full details of the techniques used are contained within the archive.

- 3.4 The general aim of the archaeological watching brief is to contribute to the understanding of the history of Sevenoaks through the recording of any archaeological remains exposed as a result of excavations in connection in connection with the ground works.
- **3.5** Particular attention is paid to the character, depth below ground level, condition, date and significance of the deposits.

4.0 RESULTS

- 4.1 No topsoil was present. The site was covered by interior and exterior hard standing Context [01] between 80mm 120mm thick. Interior hard standing was a concrete and paved floor relating to the demolished garage, while exterior hard standing was tarmac (50mm thick) and gravel base [05] (100mm thick) relating to the use of part of the area as an exterior car park.
- 4.2 Hard standing [01] overlay a compact 80mm thick layer of mid whitish yellow very sandy silt [02]. Context [02] overlay a mid/dark yellowish brown very silty sand [03] that produced 19th-century or later material. Context [03] overlay 'natural' [04].
- **4.3** Natural [04] comprised mid yellowish brown silty sand (Folkestone Beds).
- **4.4** Although modern services for No 5 High Street and a 20th-century soakaway associated with the demolished garage were noted, no significant archaeological features were revealed.

5.0 FINDS

5.1 Only context [03] contained finds, consisting of ceramic building material (CBM) and a single piece of glass.

5.2 The Ceramic Building Material by Sarah Porteus

- **5.2.1** A single fragment of brick and three fragments of peg tile were recovered from context [03]. The brick is of fine orange fabric with a scatter of fine mica and coarse iron rich inclusions and is most likely of 18th- to 19th-century date.
- 5.2.2 Two of the peg tile fragments are of typical Kent fabrics, one pinkish orange calcareous fabric and the other poorly mixed creamy yellow fabric (Canterbury Archaeological Trust codes CAT32 and CAT37 respectively). Both are likely to be of 17th- to 19th-century date.
- **5.2.3** A third peg tile fragment is under fired and brown with sparse very coarse red and black iron-rich inclusions and coarse pale silt inclusions with very coarse quartz and is probably of 17th- to 19th-century date.

- 5.3 The Glass by Elke Raemen
- **5.3.1** An aqua body sherd from a Hamilton bottle was recovered from [03]. The piece is plain, lacking any maker's marks, and dates to the late 19th to early 20th century.

5.4 Finds Assemblage Potential

5.4.1 The assemblage is too small to have any potential for further analysis. No further work is required.

6.0 DISCUSSION

- 6.1 Context [02] was a mortar floor or hard standing, while deposit [03] was the made ground base for mortar floor [02]. A late 19th-century to early 20th-century bottle fragment, together with 17th- to 19th-century ceramic building material (CBM) was recovered from deposit [03].
- 6.2 Floor/hard standing [02] perhaps related to a square building which stood on the site, first identified on the 1870 OS map (see para. 3.2.2). This building perhaps related to the previous use of the site as a public house (Greg Hendrick *pers. comm.*).

7.0 CONCLUSIONS

- 7.1 The lack of significant archaeological remains identified on the site may be due to possible terracing and truncation. However, had a high level of activity occurred on the site during any later prehistoric or early historic period, a significant quantity of residual material might be expected. No such material was identified. In view of this, it is likely that there was only a low level of activity on the site in antiquity. Consequently, the current development is likely to have a minimal detrimental effect upon the archaeological record.
- **7.2** A continuous watching brief during significant ground works is the most effective way to monitor development in areas of proven archaeological potential.




